13. Auditions

- a. Please note that the TMEA online entry process includes a 3A and 4A All-State Track (all students in Class 1A and 2A and 3A are automatically in the 3A Track, and all students in Class 4A are automatically in the 4A Track unless they submit a Track Selection with their initial entry selecting another track or TMEA 5A or 6A Track). This tracking does not apply to color instruments. Entry deadlines are standard statewide with penalties for late entries. These deadlines are built into the online entry process and cannot be changed.
 - i. All contests deadlines will be 14 days prior to the audition.
 - ii. The late and final online student entry will be 7 days prior to the day of audition.
 - iii. <u>Correction</u> to an existing student entry may be made between 13 and 7 days prior to the audition without penalty, but any <u>student entry</u> added less than 14 days but more than 7 days prior to the contest will result in an additional 100% student late fee.
 - iv. A CAMPUS entry created less than 14 days prior to the contest will be subject to the TMEA Grievance Process.
 - v. Directors will be allowed to add or change student entries the day of the audition if region rules allow it.
 - vi. 100% additional student late fees will be assessed.

- vii. All fees must be paid or supported by a school purchase order prior to the start of auditions.
- b. All entries must be accompanied by ATSSB **and** TMEA membership numbers.
- c. Per region rules Late fees will only be collected if they have to be entered by hand.

- e. Do Not use any old material!! Make sure everything is current from the site.
- f. Audition information and materials for all groups are located on this site.
- g. Entry deadlines are posted on the homepage. Late fees are not charged until entries have to be entered by hand. At that time, the entry fee is double the original audition fee amount. AT LEAST ONE STUDENT MUST BE ENTERED BY THE ORIGINAL ENTRY DEADLINE.
- h. Audition fees are \$10.00 per student for each of the concert bands. Jazz band audition fee is \$15.00 per student.
- i. If your school has ANY students entered, the **ENTIRE STAFF** is expected to attend the audition to assist/judge.
- j. High School Honor Band audition music will have NO cuts and all scales. All other auditions will consist of excerpts of the audition music and selected scales.
- k. PLEASE NOTE: Let your students who are auditioning for HS Honor Band know there is an ACT test on December10. Auditions will begin in Levelland at 1:00 pm. If your students are testing at any location other than Levelland, they could potentially miss their audition. South Plains College is one of the testing locations available for this date.
- I. Honor Band audition music is DIFFERENT from the January all-region audition music. Please refer to www.atssb.org for Honor Band audition music. All-Region audition material can be found at www.atssbregion16.com.
- m. When entering your school on the TMEA website, PLEASE INCLUDE <u>ALL</u> directors in your program.
- n. In the event of a school related audition conflict, contact the region coordinator for recording possibilities. For the Honor Band audition, the only allowable conflict (per state guidelines) is a football playoff game.
